\_\_\_\_\_ The registration information is accurate and true. Should any information change, I understand and accept responsibility to immediately notify the LEAD Office of any changes.

\_\_\_\_\_ I acknowledge and understand that I am responsible for reading and following school rules as stated in the Parent/Student handbook as all rules apply to the student parking lot. I recognize that failure to follow school rules may result in revocation of my parking sticker. I have access to a copy of the student parking lot map.

\_\_\_\_\_ I understand that any vehicle parked on District property may be subject to search if school officials have reasonable suspicion to believe that a violation of Board Policy or state or federal laws has been committed. Search of a vehicle includes all compartments and components thereof. During the search the person responsible for the vehicle will not be permitted to remove the vehicle from the premises.

\_\_\_\_\_ I recognize that failure to follow school rules as they relate to the use of my vehicle while on school property or at school functions can result in the loss of permission to park on campus, my sticker being revoked with no refund, as well as additional administrative action.

\_\_\_\_\_ The parking lot at LEAD Innovation Studio is subject to regular patrol by K-9 unit for drugs, alcohol and gunpowder.

\_\_\_\_\_ Bumper stickers and other items adhered to the vehicle must not violate school policies, including the prohibitions of harassment, discrimination, profanity and the promotion of drugs, alcohol, and other illegal substances.

\_\_\_\_\_ All vehicles must have a current LEAD permit to park on campus.

\_\_\_\_\_ Parking permits will only be issued to vehicles that have current registration and insurance coverage referenced to the student's address that we have on file.

\_\_\_\_\_ Students with outstanding fines are not eligible to purchase a parking permit.

\_\_\_\_\_ Should I change vehicles during the school year, I will return my original sticker for a replacement sticker at no cost. I understand that should I fail to return the original sticker, I will pay a replacement fee of \$5.00. All new vehicles will require a new PHS vehicle registration form and verification of a current MO registration and proof of insurance. I understand there are no refunds for parking permits.

\_\_\_\_\_ Transferring my sticker to another vehicle without administrative approval is never permitted and can result in loss of a parking sticker, disqualification for a future parking permit, and/or additional administrative consequences.

\_\_\_\_\_ I understand that stickers are not the property of the student, but are property of LEAD. Stickers are a validation of registration and indicate permission to park on campus in students designated areas only.

\_\_\_\_\_ Students may not drive or park in restricted areas. This includes all faculty lots, including handicap parking spots.

\_\_\_\_\_ Students wanting to tow trailers or other equipment must receive approval from LEAD Administration. The student must notify LEAD Administration 48 hours in advance.

\_\_\_\_\_ I understand the campus speed limit is 15 mph.

\_\_\_\_\_ I am aware that LEAD can issue fines and tow vehicles found to be in violation of parking rules.

Moving Violations (Reckless Driving, Speeding, Driving in Restricted Areas, etc.)

1<sup>st</sup> Offense - \$10 and 2 weeks suspension of parking permit.

2<sup>nd</sup> Offense - \$10 and 1 month of suspension of parking permit.

3<sup>rd</sup> Offense - Loss of parking permit with no refund.

No Permit Violations - All Offenses - \$10 fine

Parking Violations - All Offenses - \$10 fine
